

# CHURCH COUNCIL MEETING MINUTES

The Church Council of First Baptist Church of Midland, Texas met for its regular meeting on Monday, March 20, 2017. - 4. Discussion of numerical differences between worship service attendance as compared to Sunday School attendance. Dr. Wood stated that three hundred fewer people attend worship services compared to Sunday School and this is a statistic that he with the help of the ministry team, Sunday School leadership, and the Church leadership will work to change.
- 5. Communication of Church business matters to the Church. Dr. Wood stated that efforts will be made going forward to improve the overall communication of items presented and discussed at the Church Conferences. This effort is due to feedback received from Church members regarding the February Church Conference.

- 2. Defibrillator purchases. Mr. Grimes discussed the need to update and upgrade the Church's defibrillators used for emergency situations. As part of that conversation, Randall Cotton brought forth the following motion from the Finance Committee.

Motion from the Finance Committee to purchase 8 defibrillators, six for adults, one is specifically for children and one is a mobile unit, at a cost of \$6,700 to be funded from Capital Reserve. Unanimously approved.
